FAIRSFAR WILL ALSO DELIVER FAIR-RELATED ASPECTS OF THE RULES OF PARTICIPATION (ROP) AND REGULATORY COMPLIANCE FOR PARTICIPATION IN THE EUROPEAN OPEN SCIENCE CLOUD. THE EOSC GOVERNANCE STRUCTURE WILL USE THESE FAIR-ALIGNED ROPS TO ESTABLISH WHETHER COMPONENTS OF THE INFRASTRUCTURE FUNCTION IN A FAIR MANNER.


